Stefan Ambec delivers the report on the EU-Mercosur trade deal

Presented to the French government in September 2020, the report evaluates the impact of the EU-Mercosur trade deal on sustainable development

A panel of experts, commissioned by the Prime Minister and chaired by Stefan Ambec found that opening up markets will bring limited trade benefits but increase deforestation and carbon emissions.

"The EU missed an opportunity to use its negotiating power to obtain solid guarantees that meet the environmental, health and social concerns of its citizens," said Stefan. His panel has recommended substantial amendments and better impact assessments



Climate: the next threat? December 16, 2020



In the midst of the Covid-19 crisis, it is clear that the health of our bodies, economies, and our shared planet are deeply interconnected. December's special edition webinar, brought together TSE climate experts to address current and future threats, and discuss economic solutions to getting public goals, tools and policies right - worldwide - to save the planet, collectively.

During this online event, we also heard news from alumni and students who received TSE funding to launch a project. Team members William L'Heudé, Anaïs Escanes, Jaime Avila Farrar, Vincent Larrieu and Tiphaine Gouraud believe that raising carbon footprint awareness is essential in reducing greenhouse gas emissions. Their free carbon footprint calculator will encourage individuals, businesses and communities to modify their consumption patterns as existing tools are often expensive, fragmented and lacking in methodological transparency. The website is currently under development.

• The world after Covid-19, June 9 & June 22, 2020 (in French)

In June, as France was easing lockdown measures, TSE organized two webinars to debate the consequences of Covid-19. The first of these online events was open to the general public, another historic step in TSE's efforts to reach beyond the traditional research community.

Various experts including **Zohra Bouamara-Mechemache**, **Catherine Casamatta**, **Christian Gollier**, **Sophie Moinas**, **Paul Seabright** and **Jean Tirole** took the floor to explain some of the unprecedented societal, environmental and economic impacts of the current crisis, as well as suggesting policy solutions. 
